BIOGRAPHICAL/HISTORICAL NOTE:

Thomas "Tom" Rickman (1940 - 2018) was a screenwriter, playwright, and director, born and raised in Sharpe, Kentucky. He graduated from Murray State University in Murray, Kentucky in 1965 after serving three years in the Marine Corps. He received a M.A. in English from the University of Illinois, Champaign-Urbana, where he founded an off-campus theater called The Depot. He was part of AFI Conservatory's first class of 1969, and his AFI film, *WHAT FIXED ME*, won a national award for student films. He stayed involved with AFI, having written articles for AFI's magazine, *American Film*, and participated in two seminars in 197 and 198. His screenwriting credits include *COAL MINER'S DAUGHTER* (1980), *EVERYBODY'S ALL AMERICAN* (1988), *TRUMAN* (1995), and *TUESDAYS WITH MORRIE* (1999). His directing credits include *THE RIVER RAT* (1984), an episode of *ALFRED HITCHCOCK PRESENTS* (1986), an episode of *SHANNON'S DEAL* (1991), and a TV movie called *A MOTHER'S FIGHT FOR JUSTICE* (2001). Rickman was also very involved with screenwriting education. He was a charter member of the Board of Trustees of the Sundance Institute from 1981-1987 and participated in the Institute's Screenwriting Laboratory since its inception. He was also one of the founding members of the Squaw Valley Screenwriters Workshop in Squaw Valley, California in 1976. He also taught a master's course in writing at USC and participated in workshops in around the country as well as Australia, Cuba, Brazil, Canada, and Ireland.

SCOPE AND CONTENT NOTE:

The Tom Rickman Collection reflects Rickman's personal and professional life, comprising of personal and business correspondence, production and workshop documents, personal writings, scripts, newspaper and magazine clippings, research materials, and family and personal ephemera. The collection is arranged in eight series:

Series 1: Business

Series 2: Community Engagement

Series 3: Personal

Series 4: Press

Series 5: Scripts by Tom Rickman

Series 6: Rewrites and Edits by Tom Rickman

Series 7: Miscellaneous

Series 8: Oversize

The Scripts By Tom Rickman Series is arranged alphabetically by film/television show title. The materials for each title are organized chronologically. However, where chronology was unable to be determined, undated materials are placed before dated materials. This series also includes production documents and working notes belonging to their respective projects. This series also contains notes of projects, where a script may not exist. Novel drafts, while usually in the Personal series, may be found in the Scripts series if the story was turned into a script. If the author is not listed with a script, then it is assumed that Tom Rickman is the only author. If scripts were written by multiple authors, along with Tom Rickman, all names will be listed.

The Oversize Series is arranged by item format rather than film or project title due to material dimensions and container restrictions. Effort was made to arrange items to the best ability alphabetically by subseries and then by film title. The subseries are Awards, Certificates, Photographs, Posters, and Pressbook. The Oversize Series starts in boxes 45 and 46. However, items that do not fit in archival boxes are designated by O/S and number. In box 46 folder 2, there is a photocopy of framed shots of EVERYBODY'S ALL AMERICAN. The decision was made to throw away the original because of mold.
